2.1	This was an extraordinary meeting to cover one issue only the actions of the plot holders of 114b and their family.

3.1	HW - started the meeting and suggested we each add our points regarding the issue.  HW - Stated that as 2 further complaints had been made we had no choice but to take action as stated in the original letter of the 19 <sup>th</sup> August 2019.  CH - Followed and made the point that all the procedures we have in place must be adhered to.  KB - Said that the letter sent in August 2019 made mention of the children being unsupervised and running around the site and that this was long before the coronavirus pandemic. IS explained that the plot holder had the right of appeal to the trustees of the site and to L.C.C.  FT - Added that the procedures of Association cover these eventualities. He went on to read these out (these can be found in the procedure documents on the website - section 9).
