### The future of allotments in Leeds – questionnaire

We'd like to know what you think about the future of allotments in Leeds – your views are very important. **Please** read the information above each question and then tick yes or no. (All personal information you give us will be made anonymous – it will not be possible to tell which answers are yours)

This year (2013/2014), the basic rent paid to the council for a full-sized plot is £38.50 plus extra site charges (for example water charges and, for self-managed sites, insurance and other charges, depending on facilities). Next year (2014/2015), the basic rent goes up to £58, the following year to £64 and in 2016/2017 to £72. In these years, you may have to pay extra site charges to your allotment association as well as the increased rent. The council also wants to reduce the concession for state pensioners to 20%. All other concessions would be 50%, including for people receiving State Pension credits.

### 1. Do you agree with the council's proposed rent increases? Yes No

This year, as in previous years, self-managed sites keep 66.6% of the rent collected to help pay for managing, maintaining and improving the site. This amounts to £25.64 per full-sized plot. In 2014/2015, the 66.6% will be reduced to 40% and in 2015/2016 to 36%. By 2016/2017 it will be 32% – this will amount to £23.04 per plot. This is slightly less money per plot than we get this year but may be worth even less when rising costs and inflation are taken into account.

We were formed in 1917 to bring together allotment associations across Leeds and the district to work with the council for the benefit of the council and plot holders. We believe that by continuing to work with the council through the Parks and Countryside department we can help to improve the allotment service, reduce costs, introduce new ways of making income and keep rent increases to a minimum.

## 4. Do you support us to work in partnership with the council to help improve the allotment service in Leeds? Yes No

### High Court judicial review

Judicial review is a way of trying to have the council's proposals declared unlawful because they may not keep to section 10 of the 1950 Allotment Act. This act states that allotment rents cannot be increased unfairly compared with charges for similar leisure services, for example bowls, swimming, tennis and football. This could be the first time such a case has been brought in times of central government cutbacks, so it could be argued that cutbacks are an 'extreme case' as defined by the 1950 act. We have asked our solicitors for advice about taking the council to the High Court and are waiting for their reply.

Taking the council to the High Court like this is very risky and we are not guaranteed to win. Also, we don't have enough money to do this. For a legal firm to take on the case at no financial cost to us, we would have to identify any of our members who are eligible for legal aid. Or we could raise a fighting fund to pay for the court action.

### 5. Would you be willing to donate to this fighting fund? Yes No

Some of our members may be eligible for legal aid – with our support such a group of people could lead our campaign. This is a complex and sensitive issue.
